The Client also acknowledges the full awareness of the extent of this Agency Hire Service Agreement and Appendix 1 & 2 (collectively herein referred as the "Agreement") and has read and understood the terms and conditions herein on the front and back page.

OVERSEAS SURCHARGES

3. 海外附加费

In accordance to ID407 Clause 8, the Client is required to pay through KL's COEA for the foreign governments' direct fees for the FDH to exit from his/her country of origin which will be termed as Overseas Surcharges (the "Overseas Surcharges") herein:

- 3.1 For FDH of Philippines Origin, the overseas surcharge, if applicable, shall include the preparation time and material costs of the Pre-departure Orientation Seminar ("PDOS") at PHP400 and Overseas Employment Certificate ("OEC") issued by the POEA at PHP120 or OFW ID Card issued by DOLE, 2 years of OWWA membership fees at USD25, a standard mandatory medical check up which shall include X- Ray for Chest, SGPT, HbsAg, Urine Routine Test, Anti- HIV, VDRL, Stool Routine at PHP4,000, Urine for Pregnancy tests at PHP1,000 at the Philippines.

- 3.2 For FDH of Indonesia Origin, the overseas surcharge, if applicable, shall include the preparation time and material costs of airport tax, PEMBEKALAN AKHIR PEMBERANGKATAN ("PAP") issued by BNP2TKI / BP3TKI, KARTU TENAGA KERJA LUAR NEGERI ("eKTKLN"), Fiscal issued by DINAS TENAGA KERJA and Mandatory Insurance Coverage issued by any licensed insurance company for FDH and a standard mandatory medical check up which shall include X-Ray for Chest, SGPT, HbsAg, Urine Routine Test, Anti-HIV, VDRL, Stool Routine at IDR500,000, Urine for Pregnancy tests at IDR350,000 at Indonesia.

MEDICAL CHECK UP

4. 醫療檢查费

- 4.1 The Client may elect for the FDH to attend Medical Check Up A in Hong Kong at the Hong Kong X-Ray Ultrasound Medical Lab. Centre at a charge to be determined by KL from time to time. The test shall include X- Ray for Chest, SGPT, HbsAg, Anti-HIV 1/2Ab, VDRL and Blood Pregnancy tests.

- 4.2 The Client hereby agrees that under no circumstances shall KL be responsible for any differences or discrepancy of medical test results derived from any medical test centers in Hong Kong as compared with the medical test results provided by KL and/or its partnering local or overseas medical centers.

ADDITIONAL TRAINING

5. 額外培訓费

The Client may elect for the FDH to attend an additional training course in Hong Kong at a charge to be determined by KL from time to time.

OVERSEAS MANDATROY INSURANCE

6. 國外強制性保險费

If the hired FDH is of Philippines origin, the Client is required to pay for a fee for the compulsory insurance for the FDH to exit from his/her country of origin. The Client further agrees that all legal documents relating to this insurance policy shall remain in the possession of the FDH's overseas processing agent and/or with the emergency contact(s) of the FDH at the Philippines and the Client hereby agrees that no copy should be provided to the Client. For details of the policy, please refer to Philippines Republic Act No. 10022 Section 23 or visit http://www.poea.gov.ph.

7. APPLICATION PROCESSING AND PICK UP ARRANGEMENTS

7. 由請流程與接載安排

- 7.1 The following terms and conditions will apply to the Client's Application Processing and Pick Up Arrangements of General Services Clause 2.1:

 - 7.1.1 In relation to General Services Clause 2.1 and subject to the transportation availability, the Client agrees to update and re-confirm with KL on his/her preferred pick date as stated in Appendix 1, within three (3) days after a written notification of FDH employment visa approval is issued by ImmD or after the FDH's exit clearance is completed at his/her country of origin, whichever is later; and the aforementioned pick up date must fall beyond seven (7) days but within forty (40) days thereafter.

- 7.2 The following terms and conditions will apply to the Client's Application Processing and Pick Up Arrangements of General Services Clause 2.2:

 - 7.2.1 If either the FDH or the Client has offered and the counter party has accepted the FDH to begin employment at the earliest possible schedule, the Client agrees that the FDH employment visa approval date will be the commencement date of the FDH employment. As the FDH employment visa approval date is subject to the sole discretion of ImmD, the Client agrees to pick up the FDH within one (1) day after the said visa is issued by the aforementioned department; and
 - 7.2.1. 若傭工或客戶提出且相對約定方亦接受傭工儘早開始工作,客戶認可傭工工作簽證簽 發之日即為傭工工作開始之日。因傭工工作簽證簽發日期僅由入境處決定,客戶同意, 在傭工工作簽證獲籤後1天之內即接載傭工開始工作,且
 - 7.2.2 Subject to the written approval of ImmD, if either the FDH or the Client has offered and the counter party has accepted the FDH to take leave back to his/her place of origin after the commencement of the new employment contract, the Client also agrees that the FDH's employment visa validity is subject to the sole discretion of the ImmD and the FDH may be required to return to the FDH's place of origin for no less than the dates specify under the granted condition of stay and other related rules and regulations. Under this circumstance, the Client agrees to pay for the annual leave, the return air fare and the necessary food and travel allowance to the FDH and notify to KL upon the FDH's exit and return to Hong Kong;
 - 7.2.2. 在入境處的書面批准下,若傭工或客戶提出且相對約定方亦接受傭工在新僱傭合約開始後回到其原籍地休假,客戶特此同意,傭工工作簽證的有效期僅由入境處決定,且

傭工可能被入境處要求回到原籍地不少於准予逗留條件或其他相關規章制度規定的日期。在此情況下,客戶同意向傭工支付年假、回程機票及其他必要的飲食與交通補貼, 並在傭工離港、返港時當即通知本公司;或

- 7.2.3 Subject to the written approval of ImmD, if either the FDH or the Client has offered and the counter party has accepted the FDH to take leave back to his/her place of origin before the commencement of the new employment contract, KL's obligation herein this Agreement is deemed to have been completed upon the employment visa approval by ImmD and the Client agrees that KL is under no obligations whatsoever to ensure the FDH's subsequent return to Hong Kong.
- 7.2.3. 在入境處的書面批准下,若傭工或客戶提出且相對約定方亦接受傭工在新僱傭合約開始前回到其原籍地休假,客戶特此同意,本協議所規定之本公司法定義務在入境處簽發傭工工作簽證時即已全部履行完畢,本公司不對保證傭工隨後返港承擔任何責任。
- 7.2.4 In relation to Clause 7.2.2 and 7.2.3 herein, the Client agrees that, under no circumstance whatsoever, KL shall be responsible to ensure the FDH to report duty to the Client. The Client is hereby warned that the FDH may or may not return to Hong Kong at all. The Client hereby agrees to indemnify, if any, and hold KL or its employees, agents and associates harmless from all costs, penalties, damages and other losses incurred as the result of the FDH's failure to report for employment.
- 7.2.4. 就本協議 7.2.2 款與 7.2.3 款而言,客戶同意,本公司對傭工返回香港向客戶報到工作 概不負責。本公司特此提醒客戶,傭工可能返港,也可能根本不會返港。客戶特此同 意保障、保護本公司或本公司員工、代理機構或合作夥伴免受因傭工未能返港造成的 任何損失。
- 7.3 In relation to General Service Clause 2, a standard preparation of documents to assist the Client's application for the FDH's Hong Kong employment visa shall not include the Time Cost to assist the Client to provide any written reply and/or attend to any interview at any local and/or FDH's country of origin's government authority, whether it is in Hong Kong or at overseas, in case of any queries or investigations from these authorities.
- 7.3 就一般服務條款 2 為協助客戶為其所僱傭工申請香港工作簽證而準備的標準文件费用而言。準備標準文件费用並不包括因協助客戶向本地和/或傭工原籍地政府當局。無論其在香港或海外,提供任何情況下的質問或調查的書面回復和/或出席各政府當局晤面的工時费用。
- 7.4 The Client unconditionally and irrevocably agrees that any extra man hour of work and/or material cost that is being demanded by the Client outside the scope of this agreement, and agreed by KL, will be paid by the Client within 3 days upon KL's issuance of payment advice. The Client agrees that time cost per man hour of work ("Time Cost") will be fixed at HK\$1,500 and HK\$500 and each hour is divided into 10 units of 6 minutes each for KL and its COEA respectively. The minimum charge for any activity will be one-tenth of the hourly rate. In the event where the Client fails to settle KL's payment advice on time, the Client agrees that KL may, at its sole discretion, opt for Clause 11.4 or charge a 1% monthly interest on the unpaid portion of the payment advice.
- 7.4 客戶無條件且不可撤銷地同意,客戶在本協議範圍之外所要求的額外工時和/或材料成本將在本公司同意後並向客戶發出支付通知書後的 3 天內由客戶支付。客戶同意本公司及其相應海外機構的工時费用 ("工時费用") 分別為 HK\$1,500 及 HK\$500 及其每小時分為 10 個單位,每個單位為 6 分鐘,任何服務的最低工時收费將是每小時收费的十分之一。並且如果客戶未能按時支付本公司的支付通知款項,客戶同意本公司可全權酌情決定選擇執行服務條款 11.4 款或將在支付通知書的未付部分收取每月 1%的利息。
- 7.5 Referring to General Services Clause 2.1 and 2.2, the Client agrees to indemnify and hold KL or its employees, agents or associates harmless from all costs, penalties, damages and other losses incurred

- as the result of the Client's request of the FDH to report duty prior to his/her employment visa approval, or successful completion of medical check up, or reporting to respective consulate or application for a Hong Kong Identity Card, whichever that may be applicable.
- 7.5 關於一般服務條款 2.1 款與 2.2 款,客戶同意保障、保護本公司或本公司員工、代理機構或合作夥伴免受因客戶要求傭工在其工作簽證獲籤前、或完成醫療檢查前、或向領事館匯報前、或申請香港身份證等前開始工作或任何原因而造成的任何成本、懲罰、破壞或其他損失。
- 7.6 In relation to General Services Clause 2.1 and 2.2, the Client agrees to pick up the FDH at any one of the offices designated by KL, and in the event where the Client seeks KL to deliver the FDH to the Client's contractual address, the Client hereby agrees to give seven (7) days prior written notice and pay to KL a fee of HKD200.00/Km for service rendered in advance.

- 7.7 If the Client is unable to pick up the FDH, for whatsoever reason, after three (3) days of General Services 2.1 and one (1) day for General Service 2.2 after his/her arrival or employment visa approval respectively, the Client hereby agrees to pay KL HKD200 per day for addition food costs provided.

If the FDH is to suffer from any severe injury, disease, illness or death, the Client must notify KL immediately and, if required, provide KL with any assistance that KL may reasonably demand to help making such an insurance and legal claim(s).

The Client should be responsible for all employment matters and act in compliance to the terms and conditions of ID407 and all related legislations.

In such event, payment from the Client pursuant to Clauses 1.1, 1.2, 1.3, 1.4 and 1.5 shall not be refunded.

In such event, payment from the Client pursuant to Clauses 1.1, 1.2, 1.3, 1.4 and 1.5 shall not be refunded.
